The coalition committee has now announced that the extra tenders for wind energy written down in the coalition agreement are to be implemented quickly, i.e. before the end of October. Andreas Wellbrock comments: "The extra tenders for onshore and offshore projects should be launched before the end of this year. Due to the long lead times, in particular the additional offshore capacities should be allocated next year so that implementation can take place at the beginning of the 2020s."

Governor Philip D. Murphy visits Hamburg

Led by Governor Philip D. Murphy, US Ambassador to Germany between 2009 and 2013, the WAB is hosting a delegation from New Jersey. The state of New Jersey has set itself ambitious climate protection targets that can only be achieved with offshore wind energy. The governor will present the concrete expansion targets for offshore wind energy off the coast of New Jersey and promote the development of an offshore industry in New Jersey with the support of German companies.



The WAB is hosting the reception together with the Hamburg Renewable Energy Cluster. The host is SENVION GmbH. The event will take place on 17th of October from 13.00 to 14.30 hrs.
