General Terms and Conditions of Participation for sub-exhibitors at the joint stand of WAB e.V.

1. Eligibility for registration

All members of WAB e.V. shall be eligible for registration subject to the specified payment conditions. Non-members shall be charged a flat rate service charge of € 1,000 plus VAT. This surcharge shall be fully refundable provided such nonmember joins WAB e.V. before the start of the respective trade fair and half refundable if it joins no later than December 31 of the year in which it participated in the respective trade fair. Registration for participation shall always require timely submission of the completed order form of WAB e.V. with legally binding signature, specifically accepting these Terms and Conditions of Participation. The order shall be binding.

2. Payment conditions

- a. The cost share shall become due without deduction upon receipt of the invoice. The cost share is made up of partial payments and a final account.
- b. In order to ensure project liquidity and allow WAB e.V. to place the orders and make the expenditures required for preparation, the exhibitor undertakes to pay 50 % of the total price at the time of order as well as any fees incurred with the order on the part of the organiser.
- c. The remaining 50 % of the total price shall be invoiced with partial payments in accordance with the provisions of the respective trade fair organiser. The exact dates and invoice amounts shall be specified on the respective order form.
- d. If the payment deadline is not met, WAB e.V. shall have the right to terminate the contract and to otherwise dispose of the respective space.

3. Withdrawal

- a. Withdrawal by the applicant shall be admissible up to the actual order.
- b. Withdrawal or a reduction of the stand space by the exhibitor shall not be admissible following registration. If the exhibitor forgoes occupying the stand space allocated to it, the exhibitor must pay the full share amount unless WAB e.V. manages to otherwise rent or return the space.
- c. The utilisation or other use of unoccupied space by WAB e.V. itself in order to retain the overall impression shall not release the exhibitor from his payment obligation.
- d. The withdrawal of the exhibitor and/or the relinquishment of the allocated stand space shall not become effective before the respective written statement has been received by WAB e.V.
- e. All statements required under para. 3.a to 3.d have to be in writing.

4. Stand design

- a. The exhibitor shall receive from WAB e.V. and/or its partners detailed information on the stand and exhibit design and undertakes to timely meet these specifications.
- b. Individual design measures of the exhibitor shall not be admissible unless they harmonise with the external appearance and the concept of WAB e.V.'s joint stand and in any case must be coordinated with WAB e.V.

5. Insurance and liability

- a. As transport of the goods to be exhibited is the responsibility of the exhibitor, the exhibitor shall also be responsible for the insurance of the goods to be exhibited against transport risks.
- b. The insurance of the goods to be exhibited against all risks during the exhibition, in particular against damage, theft etc. shall be the exhibitor's responsibility.
- c. The exhibitor shall be liable for any damages caused to third parties as a result of its participation, including damages caused to buildings on the exhibition site, to the exhibition site and its facilities or to the trade fair stand.
- d. WAB e.V. shall not be liable in any case for damage caused to persons or property.

6. Newsletters

The exhibitors shall be informed by WAB e.V. and/or its partners with newsletters sent via email or regular mail on issues regarding the preparation and realisation of the joint attendance. The exhibitor shall be solely responsible for any consequences as a result of non-observance of these newsletters.

7. Proviso

If the event is called off due to unforeseen circumstances, WAB e.V. shall not be liable for any damages or other costs resulting therefrom to the exhibitor.

8. Final provisions

- a. Any data transmitted is stored in accordance with the provisions under the data protection law and forwarded to the competent entities during request processing and performance of the measure.
- b. For the scope of services pertaining to the attendance please refer to the “Quotation”.
- c. If the exhibitor has placed orders with WAB e.V. or its partners for any services subject to charges outside the scope of the “Quotation” or used any additional services, the exhibitor shall be charged with any costs incurred for this.
- d. Should any of the above terms and conditions be void, this shall not affect the validity of the remaining terms and conditions. These are to be interpreted in a way that the meaning and purpose of the Terms and Conditions of Participation remain intact.
