V. is presenting the "German Pavilion" (Booth 715 + 815) at the International Partnering Forum (IPF) in Virginia Beach from April 28 to May 1, represented by the Federal Ministry of Economics and Climate Action and in cooperation with the Association of the German Trade Fair Industry (AUMA).

The International Partnering Forum of the Oceantic Network is one of the largest industry gatherings of the global wind energy sector in the USA. An extensive conference program will take place alongside the trade fair.

The presentation will be accompanied by a Speaker's Corner organized by the WAB and in the conference area of a panel discussion on the topic: Global insights: 30 years of offshore wind Europe - experiences, lessons learned and future challenges. How can we, in phases with reduced slowed developments, accompany them on a positive path? What strategies can be used from the European experience?

On Wednesday, April 30, from 12:00 noon, a stand reception will be held at the German Pavilion, to which guests are cordially invited. In addition to Liz Burdock (President & CEO, Oceantic Network), delegations from Danmark, Great Britain, Netherland and Spain, have announced their attendance.
